
#### June 2024 - Total 1008 members




## Our goals

- As a non-profit, we exist to serve our members in a fiscally responsible manner.
- Give back to the membership community while maintaining strong cash position to enable this.
- Support stability, growth, and continued investment:
  - Growing IIF membership:
    - Increasing support for students.
    - Increasing engagement with practitioners.
  - Expanding **IIF influence**:
    - Increasing support for research and events.





### 2023 was a heavy investment year



- We invested heavily in 2023, generating an intentional operating loss to support key programs (M6/practitioner conference, workshops, awards, FSS, travel grants, Foresight, etc.).
- We remain in a strong financial position.
- Many thanks to all our members supporting the IIF. Also, big thanks to all those who helped solicit sponsors, and thanks to those sponsors for supporting the IIF.



### 2023 was a heavy investment year

#### Comparison of Revenue, Expenses and Net Income: 2023 vs. 2022

	January - December	January - December	YoY change
Cash Accounting	2023	2022	(%)
Revenue	419,761	448,993	-6.5
Expenses	580,383	466,118	24.5
Net Income	-160,622	-17,125	837.9

- Operating loss: \$160,622 (38.2% of revenue).
- Expenses: \$580,383, largest single-year expenditure in the history of IIF.
  - Largest increase in expenditures in workshops + FSS + awards + travel grants (+ $^{\$}$ 82K) and Foresight (+ $^{\$}$ 17K).
  - All these expenses were pre-approved, and intentional, as part of our strategy to invest in bringing more benefits to our membership.

### A look into the future

- While the IIF's financial position continues to be extremely strong, the Board will still need to ensure that it remains stable in the future.
- Some measures we are undertaking:
  - Foresight: we are pursuing a move to an online-only subscription model this would save significant printing/shipping costs, in addition to this being an environmentally friendly step.
  - Membership fees: we have increased fees and streamlined the subscription options effective 2024 March. We will continue to monitor membership, conference, and other fees as needed over time.
  - Monitoring: Treasurer will review the books every three months.

- For the past 19 years, the IIF, in collaboration with SAS®, has provided financial support for research on how to improve forecasting methods and business forecasting practice.
- Two \$10,000 grants are awarded each year: one in methodology and one in applications.
- Early career researchers are particularly encouraged to apply.





- Methodology winner: Kristen Schell (Carleton University) and Mario Arrieta-Prieto (National University of Colombia),
  - Spatio-temporal Probabilistic Forecasting of Circular Variables: Enhancing the Value of Wind Power Prospective Models by Incorporating Wind Direction Probabilistic Forecasts
- Applications winner: Xuguang Simon Sheng, (American University)
  - A Novel Method for Eliciting Business Inflation Expectations





- The IIF grants travel awards to enable individuals from all over the world to attend the International Symposium on Forecasting.
- They are primarily for students in the area of forecasting.
- There were 33 applications this year.
- Travel awards were awarded to 11 applicants from 10 different countries.





For the period from June 2023 to May 2024:

- Number of submissions: 893
- Acceptance rate: 9% (stable for the last year's 10.6%)
- Desk rejection rate and out of scope: >50%






The journal impact statistics from Clarivate/ISI were released on 21 June 2022 (for 2023).



Impact Factor values for 2023:

- 2-year IF: 6.9 (down from 7.9)
- 2-year IF (without self-cites): 6.6
- 5-year IF: 6.8



Eventually, IJF is then ranked Q1 in Economics (percentile: 96.7%) and Q1 in Management (percentile: 87.9%) We are still "negotiating" for the journal to be in the category ORMS...

### Reproducibility and open science

#### From now on:

- data and code must be shared (unless exemption is requested to EiC)
- numerical results must be replicated



### Data and code availability

New section at the end of manuscripts, disclosing availability conditions, providing links, acknowledging sources and curation, etc.

### Reproducibility checks

Performed/coordinated by a replicability editor, with the (external) support of CASCaD
